

POOL Participant Waiver, Release, Indemnification of All Claims & Covenant Not to Sue
NOTICE: THIS IS A LEGALLY BINDING AGREEMENT. Read this document carefully and in its entirety. By signing this agreement, you give up your right to bring a claim or court action to recover compensation or obtain any other remedy for any personal injury or property damage however caused arising out of your participation in our INDOOR and or OUTDOOR POOL/WATERPARK / PLAY LAND (known collectively as "Pools"), now or at any time in the future.

Acknowledgment of Risk

I hereby acknowledge and agree that participation in pool activities comes with inherent risks. I have full knowledge and understanding of the inherent risks associated with using the pools, including but not limited to (1) slips, trips, and falls, (2) aquatic injuries, (3) athletic injuries, and (4) illness, including exposure to and infection with viruses or bacteria. I further acknowledge that the preceding list is not inclusive of all possible risks associated with pool participation and that said list in no way limits the operation of this Agreement.


Coronavirus/COVID-19 Warning & Disclaimer

I understand that I will be solely responsible for any loss or damage, including personal injury, property damage, or death I sustain while participating in pool use and that by signing this agreement, I HEREBY RELEASE Releasees from all liability for such loss, damage, or death, I further certify that I am in good health and that I have no conditions or impairments which would preclude my safe participation in pool use.

I further certify that I am at least 18 years old, of lawful age to sign this agreement, and am otherwise legally competent to sign this agreement. I understand that the terms of this agreement are legally binding and certify that I am signing this agreement, after having carefully read it of my own free will.
